1. Approve FY 2021 Tentative Budget Ordinance & Appropriation:

The FY2021 Tentative Budget Ordinance & Appropriation was reviewed and discussed in the Budget Study Session. No further comments were made.

2. Set Time for Public Hearing for FY2021 Budget Ordinance and Appropriation:

3. Grove Branch Proposal:

Richie Wolf stated that he did not have anything to report to the Board. He had not heard back from Kevin Greenfield, the Chairman of the Macon County Board. President Parish recommended putting it on the April Board Agenda.

4. Volunteer Recognition Dinner:

Richie Wolf reported that the Macon County Conservation District Volunteer Recognition Dinner has been rescheduled to July 28, 2020 from the original date of April 7, 2020. He asked all Board Members to put it on their calendars.

5. Staff Reports:

In lieu of Staff giving their reports, President Parish asked if anyone had questions for the staff. No questions were asked.

Currently the Rock Springs Nature Center is closed through March 29th, all programs and volunteer hours have been suspended until April 12th and all staff are being paid to stay home until March 30th.
